Enclosed is the Schedule of Proposed Actions for the Dakota Prairie Grasslands.

Each year we conduct environmental analysis and planning for a wide variety of projects. Your participation in the analysis for these projects can promote better decisions by informing us of your concerns regarding the potential impacts of our proposed projects and by reviewing our analysis and alternatives.

This Schedule is produced quarterly and includes project proposals we anticipate working on in the coming months. Some of the projects on this list are repeated from the previous Quarter, while projects, which are just getting underway appear here for the first time.

The Schedule is not exhaustive. Analysis of some projects may start and finish before the next Schedule is published and mailed. When this happens, we will include the project in the Schedule as "completed".

The Schedule is used solely to provide notice to interested and affected agencies, organizations, and individuals of upcoming proposals, which may undergo environmental analysis and documentation. The purpose of the schedule is to give early, informal notice of proposals so the public can become aware of Forest Service activities and indicate their interest in specific proposals. It is not intended as a substitute for routine scoping described in Section 11 of the NEPA Handbook.

This schedule is not a NEPA document nor is it a solicitation for comments. Comments addressed to this schedule do not provide standing for appeal purposes. There is a contact person listed for each project, feel free to contact that person for additional information on projects that interest you.

## NEPA Decision Terms

The Forest Service documents decisions in different ways depending on the type of environmental analysis conducted to inform the decision.

**ROD (Record of Decision)** - This type of decision is used when an Environmental Impact Statement (EIS) has been produced. Decisions documented in a Record Of Decision are subject to administrative appeal.

**EIS (Environmental Impact Statement)** - This document discloses the environmental impacts to be expected from the proposed action and from specific alternatives to the proposed action. An EIS is prepared when significant environmental impacts are anticipated. Your comments are requested within 45 days of release of a Draft Environmental Impact Statement (DEIS). **Your comments are considered prior to making the final decision** and are responded to in the Final Environmental Impact Statement (FEIS).

**DN (Decision Notice)** - This type of decision is used when an Environmental Assessment (EA) is conducted and it is concluded that no significant environmental impact will result from implementing the preferred alternative. (If a significant environmental impact will result, an EIS must be prepared.) Decisions documented in a Decision Notice are subject to administrative appeal unless there has been no expression of public interest in the action.

**EA (Environmental Assessment)** - This document discloses the environmental impacts to be expected from the proposed action and from specific alternatives to the proposed action. An EA is prepared when significant environmental impacts are not anticipated or when there is a question as to the extent of the impacts. Your comments are requested within 30 days of release of an EA. **Your comments are considered prior to making the final decision** and are responded to in an appendix to the EA.

**DM (Decision Memo)** - This type of decision is used when the environmental analysis has been "categorically excluded" (CE) from documentation in an EA or an EIS. Ordinarily, decisions documented in a Decision Memo are not subject to administrative appeal.

**CE (Categorical Exclusion)** - A number of categories of action have been determined from prior experience and analysis to result in no significant impact to the environment. If a proposed action falls into one of these categories, and if no extraordinary circumstances exist which might cause a significant impact in the specific case, these actions can be "categorically excluded" from documentation in an EA or EIS. Unlike an EA or EIS, there is no formal pre-decision comment period with a categorical exclusion (except for scoping).

The following categories have been created to provide consistency in the Project Status portion of the Schedule. Please refer to this table if you have questions regarding the meaning of a specific status.

<b>Project Status</b>	<p><b>Public Involvement:</b> Public Involvement also described as scoping is an early and open process for determining the scope of issues to be addressed and for identifying significant issues related to a proposed action. During scoping the Forest Service invites participation from anyone interested in the proposed action, as well as affected Federal, State and local agencies and Indian Tribes. Scoping is often accomplished through letters, meetings, field trips, or telephone.</p> <p><b>Developing Alternatives:</b> For an EA or EIS, alternatives are developed to address issues raised during scoping. Alternatives considered in detail must respond to the purpose of the project.</p> <p><b>Analysis:</b> The analysis phase includes managing issues identified during scoping, developing alternatives to the proposed action, and analyzing effects.</p> <p><b>Comment Period:</b> There is a 30-day comment period for an EA. There is a 45-day comment period on a Draft EIS. Solicitation of comments for an EA and EIS will include a legal notice in the Forest's Newspaper of Record. The appropriate decisional document is prepared for each project. Once a decision has been made, a legal notice is published in the Bismarck Tribune or the Rapid City Journal. The next step is to implement the project.</p> <p><b>Decision Pending:</b> Comments received on the proposal will be considered in decision-making.</p> <p><b>Completed:</b> Once a Decision Notice, Record of Decision, or Decision Memo is signed it will be entered in the Schedule as completed.</p>

## Northern Great Plains Land and Resource Management Plan Revision Update

The Northern Great Plains Land and Resource Management Plan Revision process has been underway for six years. On July 31, 2002, Northern Regional Forester Bradley Powell signed the Record of Decision (ROD) for the Dakota Prairie Grasslands Revised Plan.

The legal notice was published August 14, 2002 in the Bismarck Tribune, North Dakota, and the Rapid City Journal, South Dakota. The ninety-day (90) appeal period ends November 12, 2002. Implementation began seven (7) calendar days following the publication of the legal notice August 21, 2002).
