2004 APPLICATION FOR INDIVIDUAL/UNGUIDED PERMIT**



- ❖ Each individual seeking a permit must complete a separate application.
- ❖ Each application must be accompanied by the correct fee via credit card, check or money order payable to "USDA Forest Service."
- ❖ Peak Season (July 5-August 25) permits are limited and require advance reservation.
- ❖ An unlimited number of Shoulder Season (June 1 – July 4; August 26 – September 10) permits are available after March 1.
- ❖ A maximum stay of 3 days is allowed with only one permit per 2-week period issued.
- ❖ Applications postmarked prior to February 20 (February 10 if overseas) will be returned. Hand delivered applications will be accepted after February 23. As of March 1, applications will be processed and awarded on a first come, first serve basis.

POLICIES REGARDING REFUNDS AND TRANSFERS



Before you purchase your permit, please be aware of the following policies:

❖ **Refunds:** Because Pack Creek permits are limited, refunds will be issued only in cases where the permits can be resold to another person. Accordingly, permits must be received by 5 pm, four days prior to the permit date (or the first permit date in the case of multiple day permits). The original permit must be submitted along with a completed refund request form. A postmark of four days prior is not sufficient; these two items must be received by the USFS by 5 pm, four days prior to the permit date.

❖ **Date Transfers:** Occasionally, plans change. If you would like to change the date of your visit to Pack Creek, we offer a ONE time transfer between dates ONLY if the new date is available. As with the refunds, the transfer request must be made by 5pm, 4 days prior to the permit date.

❖ **Severe Weather:** Pack Creek is located in Southeast Alaska, a region noted for fog, low clouds and high winds even during the summer months. By purchasing a permit for this remote Alaska experience, you assume the risk that weather may prevent your trip. If severe weather prevents ALL flights from arriving at Pack Creek, the permit may be transferred to a later date if that date is available. Refunds will NOT be made. In addition, once transferred due to weather, the new permit may not be submitted for a refund, even if the new date is over four days away. Severe, inclement weather is a part of life in Southeast Alaska and possibly could affect your vacation plans. If this is unacceptable, perhaps Pack Creek is not the recreation opportunity for you.

These policies are designed to be as fair as possible to all parties: original permit holders and members of the public who might otherwise obtain returned permits. By signing below, you understand and accept the above policies. If you have submitted applications for other members of your group you will be responsible to inform them of the above policies.

REFUNDS FOR UNUSED PERMITS ARE AVAILABLE UNDER THE FOLLOWING CONDITIONS ONLY:

- ❖ **The refund request form below must be completed and returned to the Forest Service Information Center. You must return your original permit with each refund request.**
- ❖ **All refunds will be subject to a \$10/person/day processing fee.**
- ❖ **PEAK SEASON permits (July 5 – August 25):**
 - **Permits must be received at the Forest Service office no later than 5pm, four days prior to permit date, or first permit date for multi-day permits. A postmark dated 4 days prior will not suffice; the form and permit must be received by the USFS by 5pm, four days prior in order to qualify for a refund.**
 - **Refunds will not be made if severe weather prevents you from arriving at Pack Creek. A ONE time transfer may be made if an alternate date is available.**
- ❖ **SHOULDER SEASON permits (June 1 – July 4 and August 26 – September 10) must be returned no later than 5pm, September 20 of the year of issuance.**

FOR EXAMPLE:

Permit for one adult on July 17 at \$50 can be refunded if returned no later than 5pm on July 13 for a total of \$40 (\$50 - \$10 processing fee).
