Located seven miles north of Portola on Country Road 126. Lake Davis is surrounded by a mixed conifer forest with beautiful mountain views. The Lake is well known for its great fishing opportunities. Supplies are available in Portola.

The following **5** campgrounds are **"Self Service"** **No fees** are charged. All have **Vault Toilets**. There is **no piped water**. Trailer space is available with the exception of Gold Lake 4X4 Camp. These sites have a 14 day limit.

Gold Lake 4X4 Camp

10 miles south of Hwy. 89 off of Gold Lake Hwy then 1 mile further 4X4 road to campground. 4-wheel drive required. Fishing

Off Hwy. 70, 6 miles northwest of Beckwourth on County Rd. 111 to Genesee. Supplies at Beckwourth. Fishing
